

Activities Meeting March 9, 2023

Marty took inventory of the music storage room. Some of the things needed repair, some were obsolete, some were new. He suggested that someone would go through the things and see what the next move will be. Cindy D. will check with the office list of inventory to see what belongs here. Perhaps some could be recycled(Free-Cycle) or donated on line.

The Yoga headsets were not working well , so Neil replaced some wiring and they seem to be working fine.

In regards to speakers at donuts, owners as well as others are expected to pay the \$75. for the opportunity to solicit. Sandy indicated that there were forms to fill out in order to rent a room when a function is not a park activity. That policy was started in 2006. Much discussion was made about paying for and soliciting, as to whether it was a board decision or an activity decision. Sandy moved and Don seconded that the board should be given the authority to and pay for private use, and ask the board to clarify. The motion was passed. Martha moved that we should turn it over to the board to determine who should be charged for the donut time, if it is for profit. Sharon D. second it, motion passed.

Cindy D. passed out papers showing activities money for the month of Jan. The beginning balance was \$14,578.68. Deposits were \$17,661.49 and Disbursements were \$5,492.62, then she explained the information.

Jerry announced this is the last week for Booster drawings. Next year the plan is to give some towards new lounge chairs and a table for the card room.

Martha said there were 35 people at chair volleyball, and they have fun.

Nancy Johnson said the next show is Saturday and tickets for next season go on sale Monday the 13th at 9:00 am. \$55. For the season pass.

Joan Fisher said the pancake breakfast went well, and the next one is Mar. 20. They are on the schedule for next year.

Bonnie said a Luau is planned for Thurs. Mar 23, 2-4:30 at the pool. Music will be played and donations taken. BYO. Judy Miedema moved and Dennis second to approve, motion passed.

Sharon said there 47 at Nickels on Monday. They will continue through the summer.

The county sent an email out concerning the use of SDP for beanbag baseball.

Neil needs money to purchase 3 headsets, Lee will use the credit card for the purchase.

The pool is under control. Neil purchased a thermometer, and would like to be reimbursed for that. Cindy D. approved the charge to activities. Most money should be turned in by April 1.

Neil moved and Don second to adjourn the meeting. Meeting adjourned at 12:20 pm.
